## **GENERAL CONDITIONS**

- Littering is considered a serious offence. Garbage is to be taken off the property or deposited in distinctly marked garbage containers near Base Camp. <u>This includes all flagging, markings or any</u> <u>identification marking for plot locations.</u>
- 2. Any destructive sampling, **particularly the destruction of trees, fish and/or wildlife** will not be permitted without the expressed permission of the owner or his designate.
- 3. Water skiing, speed boating, personal watercraft, motorcycles, mopeds, dune buggies and similar vehicles are not permitted.
- 4. Traffic rules apply any reckless or intoxicated operation of a vehicle will result in termination of use of property.
- 5. The Agreement Holder shall exercise every effort to prevent forest fires and report any fire immediately.
- 6. No firearms, including air guns and cross bows, shall be permitted without the expressed written consent of the owner or designate.
- 7. Trespassing to other campsites, cottages or hunt camps is strictly prohibited.
- 8. All Federal, Provincial and local fish and game laws must be adhered to. Mandatory creel survey is in effect. Transplanting fish deliberately or accidentally is strictly prohibited.
- 9. Access will be restricted during the fall hunt and spring break-up.
- 10. Noise must be controlled at all times. Fireworks are strictly prohibited.
- 11. Any offence against the foregoing entitles Haliburton Forest to cancel the permit without notice.
- 12. HALIBURTON FOREST & WILD LIFE RESERVE LTD. SHALL NOT BE LIABLE FOR ANY PROPERTY DAMAGE OR PERSONAL INJURY TO THE AGREEMENT HOLDER OR ASSOCIATES ARISING FROM THE USE OF THE PROPERTY OR FOR ANY OTHER REASON WHATSOEVER, NOR SHALL THE COMPANY BE LIABLE FOR ANY SICKNESSES ARISING FROM THE USE OF WATER OR OTHER CAUSE.

## **RESEARCH CONDITIONS**

13. Prior to commencement, the research proposal will be provided by the student in both written and digital format compatible to Microsoft Office. The proposal will include:

- A statement detailing the nature and objectives of the project, its scientific value and necessity, and any spatial and temporal relationship to larger or other research programs.
- > The benefits of the research in Haliburton Forest and not some other location.
- > What are the benefits to Haliburton Forest and Wild Life Reserve Ltd.
- > To the best knowledge available, include an outline of the proposed schedule of operations.

- ▶ What effect will the research have on Haliburton Forest users?
- > Will any special equipment or vehicles be required?
- > The name, address, of any agency or agencies which support, or may support, the project through advice, grants, bursaries, equipment, and supplies, etc.
- > Whether any research stations/facilities are required and the precise locations of all research sites.
- $\geq$ Copies of any valid permits you may already have from other agencies, which may govern the collection, killing, or moving of specimens or artifacts. Note that these permits or licenses, while necessary requirements, do not in themselves constitute authority to carry out the activities in question within Haliburton Forest.
- 14. A year end report either written or as part of the year end review session will be submitted to the Forester of Haliburton Forest within one year of the project start. You must complete and forward this report to continue your research the following year.
- 15. If a project is to extend beyond the 12-month period of the permit, the year-end report will be considered as a renewal of a permit.
- 16. All research locations will be provided to Haliburton Forest in a digital format compatible with ARC View GIS. All transects or plot points will be provided using UTM coordinates (NAD 83).
- 17. The home institution must provide proof of third party liability insurance of not less than \$5,000,000 for each member of the research group.
- 18. It is the responsibility of the permit holder to obtain all necessary federal, provincial and municipal permits and licenses required to conduct the research such as, but not limited to: WHIMIS sheets, Dangerous Goods certificates, Animal Cruelty permits, etc. Please keep in mind that any research involving vertebrates requires authorization from the respective University's Animal Care Committee. Before any research projects on vertebrates can commence, a signed and authorized copy of your Animal Care Protocol must be on file at Haliburton Forest. Please forward authorization with proposal.
- 19. The posting of educational material at Haliburton Forest and at research locations will be required. They will identify research goals and objectives as well as clearly identifying the home institution and a contact number for more information.
- 20. A bound copy of the thesis will be provided to Haliburton Forest. Additionally a digital copy will also be provided in a format compatible to MS and ARC View by graduation. All relevant raw data should also accompany the file report.
